

Terms of Participation and Data Protection Information: Brammibal's Donut-Voucher for Change and Plus Accounts

1. Organiser

These terms of participation apply to the marketing promotion "Brammibal's Donut Voucher" (hereinafter "Promotion") organised by Tomorrow GmbH, Neuer Pferdemarkt 23, 20359 Hamburg (hereinafter "Tomorrow").

2. Eligibility and Period

Eligible to participate are:

- New Tomorrow customers who have successfully opened a Tomorrow account from 01.06.2026 onwards and have chosen the Change or Plus account model
- Existing customers who switch to one of the new Change or Plus account models from 01.06.2026 onwards

The Promotion runs from 01.06.2026 to 31.08.2026.

3. Scope of Benefits

As part of the Promotion, eligible customers receive a monthly voucher entitling them to redeem a donut of their choice at Brammibal's Donuts (Brammibal's Donuts GmbH, Boxhagener Str. 78, 10245 Berlin, www.brammibalsdonuts.com/de/) (hereinafter "Voucher"). The Voucher is made available via the Tomorrow App.

The following redemption conditions apply:

- The Voucher is **valid for 15 minutes** from activation.
- One Voucher is provided per customer per calendar month. Unredeemed Vouchers expire at the end of the month and are not carried over.
- The Voucher may **only be redeemed during the opening hours** of the respective Brammibal's branch.
- The Voucher is redeemable at Brammibal's branches in **Berlin and Hamburg**. The branches can be found here: [Brammibal's Shops in HH und B](#).
- To redeem the Voucher, it must be presented **in its original form via the Tomorrow App**. Screenshots or other reproductions of the Voucher are not valid.

The contract for the donut is concluded directly with Brammibal's Donuts; Brammibal's is responsible for the provision of the service. Tomorrow's role is limited to providing the Voucher.

4. Reservations

4.1 Availability

The number of Vouchers available per calendar month is limited. They are issued on a first come, first served basis. Once the monthly quota has been exhausted, this will be indicated in the Tomorrow App; no further entitlement to a Voucher exists for that month. Unused quotas are not carried over to the following month.

The Voucher is furthermore only redeemable while stocks last at the respective branch. If the desired donut is out of stock at the time of redemption, or if no donuts are available at the chosen branch, there is no entitlement to redemption or replacement.

4.2 No Legal Entitlement

The Voucher constitutes a voluntary benefit without legal obligation on the part of Tomorrow. There is no entitlement to the provision, availability, or a specific value of the Voucher.

4.3 Technical Availability

Redeeming the Voucher requires a functioning mobile phone and a sufficiently stable internet connection so that the Voucher can be displayed in the Tomorrow App. Tomorrow accepts no liability if the Voucher cannot be displayed due to technical problems on the customer's device (e.g. no internet connection, battery level, device errors). In such cases too, there is no entitlement to replacement or subsequent redemption.

4.4 Amendment or Termination of the Promotion

Tomorrow reserves the right to amend, suspend, or terminate the terms of participation or the Promotion with future effect at any time, should unforeseen circumstances make this necessary. Such circumstances include, but are not limited to, technical problems, legal changes, or changed market conditions. Participants will be informed of any changes in an appropriate manner.

4.5 Exclusion from the Promotion

Tomorrow reserves the right to exclude individual participants from participation in the event of misuse or non-payment of fees due.

4.6 Cash Payment

Cash payment, exchange, or transfer of the Voucher is not possible.

5. Liability

Brammibal's Donuts is responsible for the provision, quality, and nature of the services rendered by Brammibal's Donuts. Tomorrow is otherwise liable in accordance with statutory provisions.
