

Conditions of participation: Referral Programme

Incentive

From April 4th 2023 and subject to the following conditions

- the referring person one free month of his/her existing account model for each successfully recruited person
- the referred person receives one free month of their new account model for successfully opening an account

Terms & conditions

- Every Tomorrow customer with an existing account can refer new customers. Excluded from this are employees, managing directors or shareholders of Tomorrow.
- Only new Tomorrow account openings are valid (the referred person must not have had a Tomorrow account in the last five years).
- A successful referral means when the referred person has fully opened one of the three Tomorrow account models. The decisive factor here is the identification and verification of the new customer.
- The usage of the referring person's individual referral code is mandatory.
- The amount of free months for referring persons is not limited if more than one person is referred.
- The campaign is not combinable with other Tomorrow incentives. Tomorrow Incentives, in which a combinability is indicated, are excepted from this.
- The referred persons must be at least 18 years old
- If all of the above criteria apply, Tomorrow will waive its right to the corresponding account fees in the billing month following the successful referral of the person.
- For the referring person, the additional free month is credited as followed:
 - With monthly payment: At the end of the current month in which the person did the successful referral.
 - With annual payment: At the end of the current billing cycle (12 months)
- For the person referred, the additional free month is credited as followed:
 - With monthly payment: The first month is free, in the second month the monthly subscription fee for the respective account model is due.
 - With annual payment: The first month is free, in the second month the yearly subscription fee for the respective account model is due.
- Tomorrow reserves the right to exclude referring person from referral programme if there are indications that this is being done improperly.
- By participating in the promotion, both the referring person and the referred person agree to the processing of their personal data for the purpose of carrying out the promotion. The referring person ensures that the referred person also agrees to the processing of the data for this purpose.

- Termination of the promotion: Tomorrow reserves the right to change, suspend or terminate the promotion at any time and without prior notice, in particular if this is necessary due to changes in the legal framework.
- Limitation of liability: Tomorrow is not liable for damages that arise in connection with the participation in the promotion, unless these damages are due to intent or gross negligence of Tomorrow. The liability for the injury of life, body or health remains untouched.
- As far as no legal reasons oppose, German right applies to the conditions of participation and the promotion.

Supplement to the limited special offer from February 13th 2024 to February 26th 2024

All customers who successfully invite a friend to Tomorrow in the period from 13.02.2024 to 26.02.2024 will automatically participate in the raffle for "50 x 1 year free account" together with the person they have referred.

Furthermore, both the referring and the person referred will receive a free month of their existing or new account model.

Procedure of the campaign

- The referring and referred person automatically participates as a couple in the raffle.
- On 29.02.2024, Tomorrow will draw 25 couples at random and notify the winners via email.

- Only new account openings are valid (the referred person must not have had a Tomorrow account in the last five years)
- A successful promotion is when the referred person has fully opened one of the three Tomorrow account models. The decisive factor here is the identification and verification of the new customer.
- The use of the invitation code of the referring person is mandatory.
- The referred person's account must have been opened by 26.02.2024 inclusive.
- Multiple participation is possible: If the referring person refers more than one new customer during the campaign period, she/he qualifies for the competition several times (and receives several free months). The referred person receives one raffle ticket together with the corresponding referring person.
- For the referring person the free year is credited as followed:

Supplement to the limited special offer from September 26th 2023 to October 9th 2023

All customers who successfully invite a friend to Tomorrow in the period from 26.09.2023 to 09.10.2023 will receive a Tomorrow sweater as a gift.

Furthermore, both the referring and the referred person will receive a free month of their existing or new account model.

Procedure of the campaign

- The referrer will receive a voucher code by email after the person referred successfully opened the Tomorrow account. - The voucher code can only be redeemed once per person.
- The voucher code can only be redeemed while stocks last and only on the sizes and models available at that time.
- The advertising person has no claim to size or model.

Supplement to the limited special offer from May 31st 2023 to June 7th 2023

All customers who successfully invite a friend to Tomorrow in the period from 31.05.2023 to 07.06.2023 and have not yet invested in the Tomorrow Better Future Stocks via the Tomorrow App, will automatically participate in the raffle for 30 x \in 100 starting credit for the Tomorrow Better Future Stocks.

Furthermore, both the referring and the referred person receive a free month of their existing or new account model.

Procedure of the competition

- Customer refers a new customer between 31.05.2023 and 07.06.2023.
- The referrer and the person referred both receive one free month of the existing or new account model.
- Referring person automatically takes part in the raffle.
- On 08.06.2023 Tomorrow will draw 30 winners at random and notify the winners via the Tomorrow app.
