

Terms and Conditions: Refer a Friend

Special Offer “3 Free Months” from 12 May to 09 June 2026

From 12/05/2026 to 09/06/2026 the following conditions apply

- the referring person receives 3 free months of their existing account plan for each successfully referred person
- the referred person receives 3 free months of their new account plan upon successfully opening an account

Terms and Conditions

- A person is considered referred if they are at least 18 years old, have a German tax number, and have successfully opened a current account with Tomorrow. The decisive factor is the successful identification and verification of the new customer.
- Only new account openings are valid. The referred person must not have held a Tomorrow account within the previous 3 years.
- Use of the referring person’s invitation code is mandatory. It must be entered during the account opening process in the last step before identification, under “Do you have an invitation/promotional code?” Subsequent entry is not possible.
- For the referring person, the free months will be credited after the end of the current month or current billing year.
- For the referred person, the free months will be credited before the paid period begins (monthly or annual, depending on the plan).
- Multiple participation as a referring person is possible: a referring person can refer several new customers and will receive 3 free months for each one during the promotional period.
- This campaign cannot be combined with other Tomorrow incentives, unless the other incentive provides otherwise.
- Tomorrow reserves the right to
 - exclude referrers from the referral programme if there are indications that the programme is being used abusively.
 - modify, suspend, or terminate the campaign at any time and without prior notice, in particular if required due to changes in the legal framework.
- Tomorrow is not liable for any damages arising in connection with participation in the campaign, unless such damages are attributable to intentional or grossly negligent conduct by Tomorrow. Liability for injury to life, body, or health remains unaffected.
- The invitation code is intended exclusively for private, non-commercial use within our official referral programme. Publication on third-party platforms or commercial exploitation is prohibited and may result in deactivation of the code and exclusion from the programme.
- Unless there are statutory reasons to the contrary, German law shall apply to these terms and conditions and the campaign.

- Employees, managing directors, and shareholders of Tomorrow are excluded from participation.
- Legal recourse is excluded.

Data Protection Notice:
